

## **Privacy Policy**

This Privacy Policy ("Policy") applies to Website, and Mena Stone Surfaces ("Company") and governs data collection and usage. The Company's application is a News and information application. By using the Company application, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Mailing address
- Email address
- Phone number

The Company may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Household income

We do not collect any personal information about you unless you voluntarily provide it to us. - Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest
- Enable solely internal uses that are reasonably aligned with your expectations based on your
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with

### **Children Under Thirteen**

The Company does not knowingly collect personally identifiable information from children under the age of 13. If you are under the age of 13, you must ask your parent or guardian for permission to use this application.
